1. Aspiring candidate must have appeared for MAH MCA-CET -2025 examination conducted by State CET Cell, Maharashtra & Subsequent verification of required documents at Facilitation Centre. Passed the minimum qualifying examination for MCA course at the time of spot admission.
2. The Rules of Information brochure of First Year MCA Course of State CET Cell, Maharashtra for Academic Year 2025-26 will be followed for conducting this round for filling vacant seats after CAP I, II, III & IV rounds.
3. Interested candidate should register their names along with registration form and necessary documents for respective course.
4. Documents required for Spot Admission against vacant seats:
  - a. Receipt cum Acknowledgement letter issued by Facilitation Center (FC).
  - b. All Original documents as listed in Receipt cum Acknowledgement of FC.
5. Registered candidates must report at scheduled time.
6. Candidates will be called and allotted seat as per merit number. If the seat is offered to the candidate, candidate has to pay requisite admissible fees as applicable through online mode immediately on the spot. If the candidate fails to pay the requisite fees, he/she will lose the claim of admission to the offered seat and the same seat will be offered to the next candidate as per the merit.
7. This being a dynamic round, the vacancy position for each may vary during the round.
8. The candidate having higher merit in the given category for which the vacancy is available and fulfills the required formalities along with fees on the spot if seat is offered, will have claim on vacant seat and admission will be given to such candidate.
9. Venue for Registration and Spot Admission is Rajarshi Shahu Institute of Management, Chh. Sambhajinagar.
